

## **INTERACTIVE SESSION MACA LEGISLATIVE PRIORITIES**

### Objective of this Session

MACA administers 19 statutes and several associated regulations, many of which have not been reviewed in many years. These statutes impact community governments, businesses, non-profit organizations, and residents. MACA is beginning a process to engage with stakeholders to gather information that will help us to identify priorities for changes to legislation for the future.

This session with community governments is an opportunity for elected officials to provide their thoughts related to any issues communities may have with any of the legislation that MACA administers. Input from this session will contribute to documenting issues.

### Current MACA Legislative Initiatives

- Western Canada Lottery Act – Bill is currently before the Legislative Assembly for consideration.
- Civil Emergency Measures Act – Drafting of the Bill is almost complete. The Bill is expected to be introduced during the February/March Session.
- 911 Legislation – Legislative Proposal will be submitted in February, with the Bill expected to be introduced in the September / October Session.  
**(ST-17-07-05 – 911 Emergency Services)**
- Cities, Towns and Villages Act – Legislative Proposal to be advanced in February, with Bill being introduced in the May/June Session.
- Fire Prevention Act – continuing to complete research on policy related questions that emerged from the “What we Heard Report”. A timeline for an LP is not confirmed at this time.  
**(2018-11- Fire Prevention Act)**
- ATIPP for Community Governments – MACA and DOJ will engage with community governments to assess capacity and resource requirements, and training needs. This information will help to inform community government readiness as the Bill is considered.
