


#### FEDERAL ADVOCACY

# NWTAC CONTINUED TO ATTEND AND PARTICIPATE IN FEDERAL MEETINGS, CONSULTATIONS, AND ADVOCACY OVER THE PAST YEAR.

- Federal Advocacy presentations and meetings
  - » We met to advocate for less costly, increased speed, and higher quality broadband in the Northwest Territory. We met with MP McLeod on issues that continue to affect Northern Communities and met with Minister of Infrastructure Catherine McKenna for Infrastructure Strategy Consultation.
- FCM Meetings of Board Members took place virtually from March 1 March 9, 2021, June 1 June 4, 2021, and September 9 September 29, 2021.
   NWTAC continues to be represented through the Northern and Remote Forum (currently chaired by NWTAC President, Mayor Alty), the Prairies and Territories, the Rural Forum, the Board of Directors, and various other committees and forums on FCM.

- FCM Annual Tradeshow & Conference
  - » From May 31 to June 4, 2021, the NWTAC participated in the FCM's 2021 Virtual Annual Conference and Tradeshow. The AGM is intended for municipal leaders to exchange ideas, network with peers, learn from experts and hear from all four major Federal Parties. New to FCM is the Anti-Racism and Equity Committee. Many conversations about Northern issues and concerns were brought forward to all parties, representatives, and community leaders across the country.



The Northwest Territories Association of Communities (NWTAC) prepared a Federal Election Platform to make prospective candidates aware of the issues that are important to NWT Communities.



#### HEALTHY LIVING PARTNERSHIPS

NWTAC has a project with Health and Social Services promoting, among other things, healthy traditional foods within communities and Alcohol awareness.

# THE DOPE EXPERIENCE AND SUPPORT OF THE CANNABIS EDUCATION CONSULTATION BY HEALTH AND SOCIAL SERVICES

The Dope Experience is a customizable health education workshop developed collaboratively with NWT residents in March 2019. The workshop uses creative inquiry (arts and new media) to engage young people in essential conversations about substance use, mental wellness, and the importance of caring for ourselves and each other.

## ALCOHOL STRATEGY, INCLUDING PARTICIPATION IN THE OUTREACH AND ENGAGEMENT SUBCOMMITTEE

The aim of developing an Alcohol Strategy for the Northwest Territories (NWT) is to reduce all harms experienced by the population associated with alcohol use, whether it is that of the individual or the use of alcohol by others in their household, family or community. The Alcohol Strategy will lay out concrete steps to be undertaken at the territorial level that will support improvements, remove barriers to community-led initiatives, and empower communities to address alcohol-related harms experienced by their members.



#### TERRITORIAL ADVOCACY

#### ANTI-POVERTY FOOD SECURITY

This Roundtable focused on food security and provided a collaborative space for information sharing between the GNWT, Indigenous governments, non-government organizations (NGOs), community governments, industry, and other interested parties. The NWTAC presented at the conference from a climate change context.

## INTERACTIVE SESSION WITH ALTERNATIVES NORTH FOR ANTIPOVERTY

In this session, Alternatives North presented their No Place for Poverty Coalition, 2020 Northwest Territories Poverty Report Card, and the steps governments can take to reduce poverty. They also discussed what you could do to make your community No Place for Poverty.

#### LIQUOR ACT CONSULTATION

Four meetings were facilitated by the NWTAC with Mayors, Chiefs, and SAOs. The Government of the Northwest Territories (GNWT) undertook a Liquor Legislation Review (Review) to make the liquor legislation more modern, responsive to residents' needs, and streamlined. The Review aimed to improve the NWT's liquor legislation,


specifically regarding the possession, consumption, sale, purchase, manufacture, importation and distribution of liquor in the NWT.

### PROBLEMATIC SUBSTANCE ABUSE COMMITTEE

This committee was created to engage with Indigenous Governments and Organizations, Community Governments and Non-Government Organizations to identify community-specific priorities and views, share promising evidence-based practices, and develop collaborative initiatives and approaches to addressing problematic use of alcohol and other harmful drugs within communities. The NWTAC CEO sits on this committee.


The Energy Excellence Award celebrates an NWT community that demonstrates leadership in improving energy efficiency and reducing greenhouse gas emissions.




#### NWTAC ANNUAL GENERAL MEETING



The NWTAC President's award is a special award presented at the discretion of the NWT Association of Communities' President and Board of Directors.

- Presidents Award GNWT COVID Response & Dr. Kandola
  - » The NWT Association of Communities had been so fortunate to have our Mayors and Chiefs meet regularly with the Premier and various members of Cabinet responsible for the GNWT Pandemic response. As experts in their respective communities, our Mayors and Chiefs appreciated the collaborative and respectful way they were treated throughout the pandemic as the response has evolved.
  - » We have appreciated the opportunity to not only express our challenges and concerns but to know that they were heard and actioned. It takes a unique insight to treat the community governments as important collaborators, partners, and leaders.
  - » When other jurisdictions across Canada were not encouraging outdoor activities, Dr. Kandola and the Department of Health were. She recognized how important this time outside on the land is to the mental and spiritual health of our residents. All NWT residents were so much healthier, both mentally and physically, for this approach.
  - » Dr. Kandola and Senior Staff had to make quick but informed decisions on altering the path the illness takes in the NWT and we sincerely appreciated that many of their actions or perhaps their timing have been in response to what was heard from our Mayors and Chiefs on our weekly calls and the advocacy from our Board.
  - » Whether it was through meetings with local and Indigenous Governments, during public hearings, or appearances on radio or TV, Dr. Kandola patiently explained the rationale and science behind all the decisions or approaches being taken and was always encouraging us all to be cautious, courageous, and kind to each other.


