CRTC LAUNCHES PUBLIC CONSULTATION ON NORTHWESTEL'S SERVICES

The CRTC is inviting Canadians living in the North to provide feedback on telecommunications services in the North, and particularly those offered by Northwestel.

The CRTC is seeking to better understand the state of telephone, wireless and Internet services in the areas served by Northwestel. This will help determine whether more needs to be done to ensure Canadians living there have access to high-quality services at reasonable rates.

Among other things, the CRTC is seeking comments on:

- the affordability of telecommunications services for residents and businesses in the North
- the quality of telecommunications services, including Internet speeds, mobile coverage and service reliability, and
- how the CRTC may foster competition in the North.

Canadians are encouraged to share their opinions by January 20, 2021 using one of the following methods:

All comments submitted will form part of the public record and will inform the CRTC's decision.

RAPID HOUSING INITIATIVE

In order to address urgent housing needs and create rapid affordable housing, we are excited to announce that we have launched the <u>Rapid Housing Initiative</u> (RHI).

Available to municipalities, provinces and territories, Indigenous governing bodies and organizations, and non-profit organizations, \$1 billion in funding will be available under two streams (Major Cities Stream and the Projects Stream) to support the creation of up to 3,000 new affordable housing units. To cover the costs of construction of modular housing, the acquisition of land, and the conversion/rehabilitation of existing buildings to affordable housing, RHI will issue funding directly to selected municipalities under the Major Cities Stream. All other eligible organizations will have the opportunity to apply for funding under the Projects Stream.

RHI has announced identified municipalities from the Major Cities Stream, and applications under the Projects Stream are now open until December 31St, 2020. All information will be available on the <u>Rapid Housing Initiative website</u>. As applications are now open, we encourage you to share this message with anyone you know who may be interested in supporting the development of rapid affordable housing.

CYBER CRIME

Social Engineering Fraud & Data Breaches

Criminals use various forms of communication such as email, the Internet, telephone, and even face-to-face interaction to infiltrate companies. The main objective for these criminals is financial gain.

An example of how easily it can happen.

Pointe Claire-based Future Electronics has accounts payable staff in Singapore. They were duped into making electronic funds transfers to bank accounts controlled by criminals who impersonated the chief financial officer of a legitimate supplier. Those payments were made towards legitimate invoices received from the supplier. So while the invoices were sent by actual employees of the supplier, the instructions to change the supplier's banking information were not. So the criminals fooled the insured's accounts payable staff into transferring the money to the criminals' bank account and not the supplier's actual bank account.
