Who Can Apply to a Challenge Stream?

Are you an innovator with a great solution that prevents and/or diverts food waste? Or are you trying to advance a technology that can extend the shelf-life of food or transform food waste? If so, the Food Waste Reduction Challenge is for you!

We are inviting innovators of all types and sizes to apply to one of the four streams of the Food Waste Reduction Challenge. International applicants with a Canadian partner or an ability to register to do business in Canada are encouraged to apply. Ideas and concepts can originate from anywhere globally, but to receive funding under the Challenge, the solutions presented in the submissions must be developed, tested, piloted, demonstrated, and deployed in Canada.

We are currently accepting applications for Challenge Streams A and B.

Application intake for these streams closes January 18, 2021.

Please see the <u>Applicant Guide</u> for more eligibility details. Applications for Streams C and D will open in Spring 2021.

Up to 30 Prizes of \$100,000 Open to all eligible innovators submitting a concept application at Stage 1. Up to 12 Prizes of \$400,000 Open to all Semi-Finalists who reach Stage 2. Up to 2 Grand Prizes of \$1,500,000 Open to all Finalists who reach Stage 3.

CRTC LAUNCHES PUBLIC CONSULTATION ON NORTHWESTEL'S SERVICES

The CRTC is inviting Canadians living in the North to provide feedback on telecommunications services in the North, and particularly those offered by Northwestel.

The CRTC is seeking to better understand the state of telephone, wireless and Internet services in the areas served by Northwestel. This will help determine whether more needs to be done to ensure Canadians living there have access to high-quality services at reasonable rates.

Among other things, the CRTC is seeking comments on:

- \cdot the affordability of telecommunications services for residents and businesses in the North
- \cdot the quality of telecommunications services, including Internet speeds, mobile coverage and service reliability, and
- how the CRTC may foster competition in the North.

Canadians are encouraged to share their opinions by January 20, 2021 using one of the following methods:

All comments submitted will form part of the public record and will inform the CRTC's decision.

COVID-19

COVID ALERT APP

The Northwest Territories

is now covered by the federal government's CovidAlert app, allowing residents to report Covid-19 diagnoses for contact tracing purposes.

The COVID Alert app is free and voluntary, and is another tool to help limit the spread of COVID-19. Users who test positive for COVID-19 will receive a one-time key from their health authority that they can enter into the app. When the key is entered, COVID Alert will notify other users who may have come in close contact with that person for at least 15 minutes, and direct them on next steps based on their provincial or territorial public health advice.

To safeguard the confidentiality and privacy of all Canadians, the app uses strong measures to protect any data it collects, and does not track a user's location or collect personally identifiable information. The Privacy Commissioner of Canada continues to be engaged on COVID Alert, and supports its use by Canadians.

GNWT IS ACCEPTING APPLICATIONS FOR THE 2021 ANTI-POVERTY FUND

Yellowknife (November 18, 2020) – The Government of Northwest Territories is pleased to announce that it is now accepting applications for the 2021 Anti-Poverty Fund. The annual \$1 million Fund can be used to support poverty reduction initiatives in NWT communities.

NWT Indigenous governments and community governing authorities as well as non-government organizations who demonstrate partnership or support from an Indigenous or community governing authority can apply for funding.

Eligible projects must be located in the NWT and must align with at least one of the Territorial Anti-Poverty Strategy priorities:

- · Children and Family Support
- · Healthy Living and Reaching Our Potential
- Safe and Affordable Housing
- Sustainable Communities
- Integrated Continuum of Services

Application deadline is January 31, 2021.

CANADA RECOVERY SICKNESS BENEFIT

CANADA RECOVERY SICKNESS BENEFIT (CRSB)



Government of Canada

Income support to employed & self-employed individuals unable to work because they are sick or need to self-isolate due to COVID-19, or have underlying health conditions and are at greater risk of getting COVID-19 • The Canada Recovery Sickness Benefit is available for one

year, from September 27, 2020 to September 25, 2021.

• The benefit provides \$500 per week for up to a maximum of two weeks, for workers who:

• are unable to work for at least 50% of the week because they

contracted COVID-19,

• are self-isolated for reasons related to COVID-19, or

• have underlying conditions, are undergoing treatments or have contracted other sicknesses that, in the opinion of a medical practitioner, nurse practitioner, person in authority, government or public health authority would make them more susceptible to COVID-19.

• NWT employees who do not have sick leave coverage with their employers qualify for the Canada Recovery Sickness Benefit.

INDIGENOUS PEOPLES RESILIENCE FUND



Indigenous Peoples Resilience Fund

The Indigenous Peoples Resilience Fund (IPRF) is an Indigenous-led effort to respond to urgent

community needs while taking a long-term view on building community resilience.

The Fund is governed by an **Indigenous Advisory Council** that approves all governance, resilience fund projects, communications and fund-raising strategies and recommendations related to the work of fulfilling the purpose of the IPRF.

Any Indigenous-led organization or Indigenous-serving organization working to foster resilience in Inuit, Metis and First Nations communities anywhere in Canada can apply for resiliency funds ranging from \$5,000 to \$30,000. For examples of eligible projects, see the Applicant Guide.

FUNDING OPPORTUNITY



RAPID HOUSING INITIATIVE

In order to address urgent housing needs and create rapid affordable housing, we are excited to announce that we have launched the **Rapid Housing Initiative (RHI)**.

Available to municipalities, provinces and territories, Indigenous governing bodies and organizations, and non-profit organizations, \$1 billion in funding will be available under two streams (Major Cities Stream and the Projects Stream) to support the creation of up to 3,000 new affordable housing units. To cover the costs of construction of modular housing, the acquisition of land, and the conversion/rehabilitation of existing buildings to affordable housing, RHI will issue funding directly to selected municipalities under the Major Cities Stream. All other eligible organizations will have the opportunity to apply for funding under the Projects Stream.

RHI has announced identified municipalities from the Major Cities Stream, and applications under the Projects Stream are now open until December 31St, 2020. All information will be available on the **Rapid Housing Initiative** website.

As applications are now open, we encourage you to share this message with anyone you know who may be interested in supporting the development of rapid affordable housing.


